Sir/Madam,

In continuation of this Ministry's letter of even number dated 01.02.2018 and your letter No.1228/GEMS/MBBS-100to150Seats/2018 dated 03.03.2018 furnishing required undertaking and Bank Guarantee, I am directed to convey the formal permission of the Central Government to your College for increase of intake capacity from 100 to 150 in MBBS course for the academic year 2018-19 under Section 10 A of the IMC Act, 1956.

2. This permission of the Central Government is accorded initially for a period of one year and will be renewed on yearly basis subject to verification of achievement of annual targets as indicated in your scheme. This process of renewal of permission will continue till such time the infrastructure and expansion of hospital facilities are completed as per norms of Medical Council of India and the College is recognized. The next batch of students against increased intake shall be admitted only after obtaining permission of the Central Government.

3. Admissions made in violation of the above conditions will be treated as irregular and action under IMC Act, 1956 & Regulations made thereunder will be initiated.

4. The Government Medical Colleges (except those located in J&K State) shall contribute 15% of MBBS seats for which the renewal permission is granted for all India quota.

5. Discrepancies, if any, may be brought to the notice of MCI and Central/State Government.

The fee collected by what so ever name called either for University quota seats or for management seats should not exceed the limits specified by the State Government / Dr. NTR UHS from time to time.



