ORDER:

As per the recommendations of statute on affiliation of colleges of Nursing adopted by the Executive Council of Dr. NTR UHS., in October, 1996 and as amended in July, 2003 and as per the permission accorded by Government of A.P, Hyderabad and INC, New Delhi vide reference 1st & 2nd cited & basing on the report of the inspection committee vide reference 8th cited, it is hereby certified that the application of **Great Eastern Medical School (GEMS) College of Nursing, Srikakulam** Sponsored by Aditya Educational Society, Srikakulam for starting of B.Sc. Nursing 4 YDC Course has been registered with the Dr.NTR University of Health Sciences, Vijayawada Provisional affiliation is granted for starting **3rd Year B.Sc(N) 4 YDC Course** and for admitting the students with an intake of **80 (Eighty)** seats for the academic year **2018-19** and **subject to final orders of the Supreme Court of India regarding submission of renewal of permission from Indian Nursing Council, New Delhi for the academic year 2018-19.**

Further the Principal of the institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical facilities etc., throughout the academic year, as stipulated in Regulation of INC, New Delhi/ Statutes of Dr. NTR UHS, Vijayawada.

The Number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management quota as specified by the Indian Nursing council / Dr.NTR UHS.

The fee collected by what so ever name called either for University quota seats or for Management seats should not exceed the limits specified by the State Government / Dr.NTR UHS from time to time.

The college authorities shall follow the regulations made by the State Government / Dr.NTR University of Health Sciences / Indian Nursing Council in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any violations in this regard may lead to disaffiliation of the college without any notice.

*** Pre-requisitions and Conditions :**

1. Shall obtain permission of the APNMC, Vijayawada every year.
2. The Physical facilities, clinical facilities, teaching and other staff should be as per the Norms of Indian Nursing Council, New Delhi and as per Dr.NTR UHS Statutes.
3. The Dr. NTR UHS may conduct surprise inspections at any time for verification of college facilities.
4. Incase if any of the information furnished by the Institution is false or misleading the University has a right to withdraw the permission without further notice.
