# Rules & Regulations Regarding Admissions

After seat allotment by Dr. YSR University of Health Sciences, Vijayawada, for UG/PG Medical Courses in Great Eastern Medical School & Hospital, Ragolu, Srikakulam District the students should follow the Rules & Regulations regarding their admissions.

- 1. The prescribed Tuition fee is to be paid before the admission and obtain the valid receipt from accounts department.
- 2. After the payment of prescribed fee, they should submit all the original certificates, get them verified by the admission committee.
- 3. They should also submit all the annexures required for admission.
- 4. 80% of the theory & practical attendance is mandatory to become eligible to appear for University Examinations.
- 5. Tuition fee is to be paid once in every year before entering into next year course.
- 6. In case of discontinuation from the course at any time, the student should pay entire course fee prescribed for the total course and apply for discontinuation.

That I am aware of the fact that W. P. No. 32975 of 2022 were filed and the Hon'ble High Court of A.P., gave the following direction in I. A. No. 2 of 2023 in W. P. No. 32975 of 2022, "Upon hearing both the counsel, this Court deems it appropriate to enhance the existing fee for the academic year 2022-2023 at the rate of 15% for the present year 2023-2024 for MBBS-PG and Super Specialty Courses, in the interest of justice, keeping in view of the inflation and other factors.

Therefore, the State Government is directed to go ahead with the Counselling notification in respect of MBBS PG and Super Specialty Courses medical admissions.

The Respondents are further directed to notify the enhanced fee for the academic year 2023-2024 at the rate of 15% as a tentative fee till the fixation of final fee as per the procedure under the provisions Act 20 of 2019 and Rules made there under, which is pending before the APHERMC".

As per the above Orders, the Government of Andhra Pradesh issued G. O. Ms. No. 123, HM&FW (C1) Dept., Dt. 10/08/2023 notified the fee structure for the academic year 2023-2024 by enhancing the rate of 15% on the existing fee of the academic year 2022- 2023 which was notified in the G. O. Ms. No. 56, HM&FW C1) Dept., Dt. 29/05/2020 to the PG Medical and Dental Courses pending fixation of the final fee. The G.O. further stated that the fee structure notified is subject to outcome of the W. P. No's. 32975-33162 and 35090 of 2022.

I am herewith paying the tuition fee as per the above orders of the Government of Andhra Pradesh (G. O. Ms. No. 123, HM&FW (C1) Dept., Dt. 10/08/2023), I further undertake, without prejudice to my rights, I agree to pay the tuition fee payable pursuantto the decision of the Hon'ble High Court in above batch of Writ Petitions or by the Hon'ble Supreme Court of India or Order of the Government or any other authority concerned.
